Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
- 5. Interested bidders may obtain further information from the Bids and Awards Committee and inspect the Bidding Documents at the address given below during office hours at eight o'clock in the morning to five o'clock in the afternoon.
- 6. A complete set of Bidding Documents may be purchased by interested Bidders on *March* 10-18, 2020 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *One Thousand Pesos (Php1,000.00)*.
- 7. Bids must be delivered to the address below on or before *March 19, 2020 at 3:00 in the afternoon*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

- 8. Bid opening shall be on March 19, 2020 at 3:00 in the afternoon. at BAC Office 2<sup>nd</sup> Floor Municipal Bldg, Dinahupihan, Bataan. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
