INVITATION TO APPLY FOR ELIGIBILITY AND TO BID
INFRA-PB-2024-01-002

“CONSTRUCTION OF BARANGAY ROAD, DAVID ST., BRGY. BAYAN-BAYANAN, DINALUPIHAN, BATAAN”

1. The LGU Dinalupihan, Bataan, through DBP LOAN for the contract approved by the Municipality of Dinalupihan for 2024 intends to apply the sum of **ONE MILLION NINE HUNDRED NINETY-NINE THOUSAND ONE HUNDRED NINETY-NINE PESOS & 67/100 ONLY (P 1,999,199.67)** being the Approved Budget for the Contract (ABC) to payments under the contract **CONSTRUCTION OF BARANGAY ROAD, DAVID ST., BRGY. BAYAN-BAYANAN, DINALUPIHAN, BATAAN**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The LGU Dinalupihan, Bataan now invites bids **CONSTRUCTION OF BARANGAY ROAD, DAVID ST., BRGY. BAYAN-BAYANAN, DINALUPIHAN, BATAAN**. Completion of the Works is required **Thirty-Four (34) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.
4. Interested bidders may obtain further information from **LGU Dinalupihan, Bataan** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 19, 2024** from Municipal Treasury Office LGU Dinalupihan, Bataan and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00)**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees either by physical or electronic means.
6. The LGU Dinalupihan, Bataan will hold a **Pre-Bid Conference on January 29, 2024 at 9:30 am** at Executive Hall, Municipal Building and/or through videoconferencing/webcasting via zoom which shall be open to prospective bidders
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below. **Late bids shall not be accepted.**
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on **February 12, 2024 at 9:30 am** at the given address below and/or through zoom. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

10. The LGU Dinalupihan, Bataan reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
