

**Contract Agreement for the  
Procurement of Garbage Collection Services (2<sup>nd</sup> Quarter 2026)**

THIS AGREEMENT, made this 14<sup>th</sup> day of April 2026 between the Municipal Government of Dinalupihan, a local government unit with principal address at Barangay San Ramon, Dinalupihan, Bataan, herein referred to as the MUNICIPALITY represented by its Municipal Mayor, HON. GERMAN M. SANTOS JR. and AS MACHA CONSTRUCTION AND TRADING, represented herein by Mr. ALFREDO S. MACHA, Owner/Proprietor, with office address at 216 Fatima Subd. Sapa, Samal, Bataan herein referred to as the "Supplier".

WHEREAS the Entity invited Contractor for the Procurement of Garbage Collection Services (2<sup>nd</sup> Quarter 2026) and has accepted a Bid by the Contractor in the sum of Five Million Two Hundred Seventy-Five Thousand Pesos Only (Php5,275,000.00), hereinafter called "the Contract Price".

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- a. Schedule of Requirements;
- b. Technical Specifications;
- c. General and Special Conditions of Contract; and
- d. Supplemental or Bid Bulletins, if any

Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and


Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**


3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
