SECOND PARTY

with office address at Barangay San Ramon Dinalupihan Bataan, represented herein by **Ms. Jennifer S. Pruna**, hereinafter referred to as the "**SECOND PARTY.**"

WITNESSETH:

WHEREAS, the FIRST PARTY is organizing the **108th Dinalupihan Foundation Day** celebration;

WHEREAS, the FIRST PARTY desires to engage the professional services of the SECOND PARTY for Sounds and Lights, Roofing dome, Roofing for tech booth, stage, live feed, led wall, crash barricade and genset for the said event;

WHEREAS, the SECOND PARTY has the authority and capability to provide the required tech requirements and related services.

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

4. FORCE MAJEURE

Neither party shall be held liable for failure or delay in the performance of its obligations due to events beyond reasonable control, including but not limited to natural calamities, government restrictions, or similar force majeure events.

RE-SCHEDULING OF PERFORMANCE

5. Re-scheduling Due to Typhoon or Heavy Rain

In the event that the performance is affected by typhoon, heavy rain, or severe weather conditions, the FIRST PARTY shall inform the SECOND PARTY at least two (2) days prior to the scheduled event date that the event shall be re-scheduled.

In such case:

- The event shall be re-scheduled to a mutually agreed date; and
- No additional payment, penalty, or charges shall be required from the FIRST PARTY beyond the agreed talent fee.

5.1 Re-scheduling Due to Acts of God

In the event of Acts of God (including but not limited to natural disasters, government-imposed restrictions, or other unforeseen events beyond the control of both parties):

- a. The parties shall enter into good faith negotiations to re-schedule the event;
- b. If all the equipment/tech ride are already set up at the venue (before the show the supplier starting to set up) at the time the event is cancelled or postponed, the FIRST PARTY shall pay the 100% of the total amount.

6. TERMINATION

This Agreement may be terminated by mutual written consent of both parties or due to material breach, subject to applicable laws, rules, and regulations.

7. GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the **Republic of the Philippines**.
