

Contract Agreement for the  
Purchase and Delivery of Medical Supplies for Dialysis Center

THIS AGREEMENT, made this 25<sup>th</sup> day of March, 2026 between the Municipal Government of Dinalupihan, a local government unit with principal address at Barangay San Ramon, Dinalupihan, Bataan, herein referred to as the Entity represented by its Municipal Mayor, HON. GERMAN M. SANTOS JR. and 777 RED PHARMA INC. represented by Mr. JESS RICHARDSON P. RECAIDO, Authorized Representative, with postal address at L16 B25 Bonifacio Ave, Cor. Jaena St., Kalayaan Village, Quebiawan, San Fernando City, Pampanga, herein referred to as the "Supplier".

WHEREAS the Entity invited Bids for the Purchase and Delivery of Medical Supplies for Dialysis Center and has accepted a Bid by the supplier in the sum Two Million Four Hundred Ninety-Seven Thousand Pesos (Ph2,497,000.00), hereinafter called "the Contract Price".

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and





The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
