"CONCRETING OF BARANGAY ROAD IN TAMBAKAN STREET JC PAYUMO"
TAMBAKAN ST., BRGY. J.C. PAYUMO JR., DINALUPIHAN, BATAAN

1. The LGU Dinalupihan, Bataan, through the **20% Development Fund** for the contract approved by the Municipality of Dinalupihan for 2026 intends to apply the sum of **ONE MILLION NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-SEVEN PESOS & 8/100 ONLY (P1,999,997.08)** being the Approved Budget for the Contract (ABC) to payments under the contract **CONCRETING OF BARANGAY ROAD IN TAMBAKAN STREET JC PAYUMO**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The LGU Dinalupihan, Bataan now invites bids **CONCRETING OF BARANGAY ROAD IN TAMBAKAN STREET JC PAYUMO**. Completion of the Works is required **Twenty-Two (22) calendar days**. Bidders should have completed, within 10 years from the date of submission and receipts of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 12009 (RA 12009), otherwise known as the "New Government Procurement Act (NGPA)".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **LGU Dinalupihan, Bataan** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm, Monday to Friday**.

5. A complete set of Bidding Documents may be acquired by interested Bidders on **April 29, 2026** from Municipal Treasury Office LGU Dinalupihan, Bataan and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P5,000.00)**.

6. Pre-Bid Conference – None.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below. Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.

9. Bid opening shall be on **May 18, 2026 at 11:30 am** at the given address below and/or through zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. Relevant Requirement: PCAB License Small B

11. The **LGU Dinalupihan, Bataan** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70 of R.A. No. 12009, without thereby incurring any liability to the affected bidder or bidders.
